

PREPAID BATTERY RECYCLING PROGRAM ORDER FORM PROGRAM FEATURES:

- Containers that have the *maximum capacity* to hold up to **30 pounds** (small box) or **70 pounds** (large box) of batteries.
- The convenience of one price, which includes the cost of the containers, recycling and UPS transportation.
- UPS transportation is included from any of the contiguous United States, as well as Hawaii, Alaska, Puerto Rico and Canada.
- Packages to be used only for consumer sealed cell dry batteries.

PLEASE RETAIN A COPY OF THIS ORDER FORM FOR YOUR RECEIPT

To guard against possible fire, it is imperative that the collector/shipper of the batteries take one or more of the following precautions to prevent the batteries from short-circuiting:

- Place plastic non-conductive electrical tape over the terminals.
- Package the batteries in a manner that will prevent the terminals from contacting other batteries or metal surfaces during storage or transport.
- Place the batteries in plastic bags: If this option is used, each battery should be placed in a separate plastic bag so the terminals will not come in contact with other batteries or metal during storage or transport.
- Discharge Cells: Only a knowledgeable engineer or technician should do this.
Consult your battery supplier for instruction on how to discharge cells completely and properly.
